ORDER

A Criminal Calendar Call is presently scheduled for Judge R. Chris Phelps for the Superior Court of Madison County, Georgia on February 6, 2026, at which all parties and counsel shall be present at the time specified on Exhibit "A".

IT IS HEREBY ORDERED:

The cases set forth on Exhibit "A" attached hereto shall constitute the "preliminary" **Trial Calendar** for the week of March 30, 2026 through April 2, 2026, subject only to any jail cases and cases in which statutory speedy trial demands have been filed. The cases set forth (excepting a speedy trial demand or jail case) are indicted or accused prior to January 1, 2024, and thus, absent good cause shown, are presumed ready for trial. Absent notice provided to the Court on February 6, 2026, the Court will further presume that defense counsel is in touch with and has accurate up-to-date contact with Defendants/clients.

The District Attorney's Office shall advise the Court on February 6, 2026 of any pending jail cases and statutory speedy trial demands that should have priority for trial.

The cases set forth listed on Exhibit "A" shall be called at the time(s) specified therein at Calendar Call, but counsel are advised that the order of cases for trial may change with the publication of the Final Trial Calendar. Counsel and the parties shall be ready for trial, including having witnesses subpoenaed and available.

Counsel are advised as follows: An announcement of "Ready for Trial" shall mean the following: All discovery has been exchanged. All photos, videos, body and dash cams, crime lab reports and all other evidence of the State have been provided to the Defendant. Due to the age of the cases all such material should be in the possession of the State. All potential witnesses and evidence of the Defendant has been provided to the State. Due to the age of the cases all such material should be in the possession of counsel for the Defendant. Both the State and Defense have contacted their respective witnesses and the witnesses are available during the trial week.

The Court will accept any negotiated or blind pleas on February 6, 2026, and accept any negotiated or blind pleas **and** hear any pending Motions on February 16, 2026, commencing at 9:30 o'clock A.M. and on March 20, 2026, commencing at 9:30 o'clock A.M. **It shall be the responsibility and obligation of the moving party to cause a Rule Nisi to issue for the hearing of any pending Motion(s) for either February 16, 2026 or March 20, 2026. Any pending Motions not scheduled and brought for hearing on one of said dates, absent good cause shown, shall be considered abandoned.**

The Court will enter a "Final" Order for the Trial of Cases for the week of March 30, 2026 through April 2, 2026 at least ten (10) day in advance of the trial week.


This Order sets forth three (3) dates on which guilty pleas may be entered or cases otherwise disposed of: February 6, 2026; February 16, 2026; and March 20, 2026.

No continuance or removal from the Trial Calendar shall be granted except for good cause, and any such request shall be brought to the Court's attention prior to March 27, 2026.

Counsel shall **strictly** and **timely** comply with Rule 17.1(B) of the Uniform Rules for Superior Courts in regard to any conflicts for all four (4) dates set forth, which includes the week of trials.

Leaves of Absence filed by counsel after an announcement of “ready for trial” will be considered untimely and ineffective as to the trial week.
